

“Phibsborough Dental & Medical Clinic Membership Plan”

Terms and conditions

1. Definition

in these terms and conditions except where context requires otherwise:

“**Phibsborough Dental & Medical Clinic Membership Plan**” is the service provided by “Home Care Clinic Ltd” t/a Phibsborough Dental & Medical Clinic for which you pay once off fee and is valid for 12 consecutive months. Its validity starts 14 days after the membership’s payment. Details of the service are outlined hereunder.

“**The Practice**” means “**Phibsborough Dental & Medical Clinic**” operated by “Home Care Clinic Ltd.”

“**Home Care Clinic Ltd.**” means the company providing general medical services and its successors and assignees whomsoever.

“**Patient’s card**” means a plastic card issued to each member which contains printed name and surname of its holder, a face photo, expiry date and bar code.

“**The Contract**” consist of the offer outlined in these Terms and Conditions, the signed “**Phibsborough Dental & Medical Clinic**” membership application form and these terms and conditions.

2. Treatments to which you are entitled

The Contract entitles you to medical care from “**Phibsborough Dental & Medical Clinic**” medical practitioner as follows:

-General Medical Practitioner for consultation. The membership allows TO FREE AND UNLIMITED GP consultations in “The Practice” until the membership’s expiration date. The membership is *not* limited by age of prospective member.

-The appointment can be made according to practitioners working hours by contacting “The Practice” and from Monday to Friday except bank holidays or reasons beyond our control or because of Act of God.

3. Treatment to which you are not entitled

The Contract does *not* entitle you to services provided by: General Medical Practitioner other than consultation, specialist, practitioners who are in progress of specialists registration having general medical registration in IMC registry except Family Medicine Division, dentist

The Contract does *not* entitle you to services:24 hour care, home visits

4. Treatment by another practitioner

The Contract is with Home Care Clinic Ltd. alone.

5. Prescriptions and laboratory charges

The Membership Plan does *not* cover you for pharmaceutical prescription costs or laboratory charges.

6. Your responsibilities

You must attend any appointments made with “The Practice” and pay any “missed appointments fee” reasonably imposed on you which is €50.

You *must* produce “Patient’s Card” on arrival at the Practice reception. The Practice staff has a right to ask for another form of your identification.

7. Additional charges

Please be aware that “Home Care Clinic Ltd.” reserves the right to charge additional fee not covered by Membership plan if during the consultation it emerges that the consultation and investigation would be outside or over and above that considered to be a standard basic consultation which is covered by Membership Plan. If it becomes necessary to charge an additional fee (ie. for Urinalisis or ECG done during the consultation) it will be discussed with you directly by the doctor whom you attended the consultation and who will outline the reasons behind the additional fee being charged.

8. Payment

Payment for “Membership plan” can be made by cash, credit and debit cards and must be made by person intending to purchase Membership as a face photo will be taken at the clinic’s reception upon purchasing “the Membership”. The fee must be paid in full before the first General Medical Practitioner consultation to which entitles you the Membership Plan.

9. Transfer of contract

Contract is *not* transferable.

10. Patient’s Card:

-Is *not* a family card and entitles to membership’s benefits *only* the person whose name and surname is printed on the card

-Is *not* a cheque guarantee, credit or charge card

- May *not* be exchanged for cash

-Will be issued within 10 working days to each new “Phibsborough Dental & Medical Clinic” member

-The cost of issuing duplicate of lost/stolen card is €10 and waiting time is 10 working days

11. The Contract renewal

The Contract will not be automatically renewed upon expiration.

12. Termination of The Contract

-You may terminate the Contract at any time during its validity although no fee will be returned to you by Home Care Clinic Ltd.

13. Acknowledging the terms and conditions of The Contract

By signing the “**Phibsborough Dental & Medical Clinic Membership Plan**” application form you acknowledge these Terms and Conditions and that this Contract is between you and “Home Care Clinic Ltd” and that there is no contract between you and General Medical Practitioner you are attending.

14. Change of Terms and Conditions
